

 - Power button (Slide up/down)


NOTE: Please note that the original headphones need to be connected as the cable is working as the radio antenna. Cannot be connected to other headphones or amplifier by AUX cable.

_	Long	Volume down fast	Steps 0-15
+	Long	Volume up fast	Steps 0-15

Tuning the radio

Symbol	Press	Function	Options
	Short (repeating)	Set frequency manually up / down	Steps 0.1 MHz
\blacktriangle \blacktriangledown	Long	Auto search next station up / down	Search and stop
Q	Long	Auto-scan all stations	Auto-store P01-P30
Q	Short (toggle)	Go to stored stations	P01-P30
